

## General information

The P12-3 oil field was discovered in 1983 by Pennzoil Nederland CO. by well P12-03. The field contains oils in the Rijn Member (KNNSI), which was the original secondary target. The primary target of the Main Buntsandstein Subgroup (RBM) only displayed gas shows.

The P12-3 oil field is largely situated at the western margin of the West Netherlands Basin with part of the field in the Winterton Platform. The field is located in the P12 concession of Wintershall, 46 km of the Dutch coast.
